The H. Lavity Stoutt Community College invites tenders for **EXTERMINATING SERVICES** at the H. Lavity Stoutt Community College Paraquita Bay Campus which includes the North and South Campuses commencing 1 August 2025.

Background Information:

The H. Lavity Stoutt Community College (HLSCC) is a statutory body of the Government of the Virgin Islands, established on 14 January 1990, to serve as an institution of higher learning, offering instruction across various fields of education. It operates under the Ministry of Education, Youth Affairs and Sports, guided by an appointed Board of Governors.

HLSCC is desirous of having an **EXTERMINATING**

CONTRACT for the 2025/2026 and 2026/2027 academic years. The period of the contract in the first instance is from 1 August 2025 through 31 July 2027.

Terms of Reference:

The following should be taken into consideration when submitting the tender:

- HLSCC is inviting proposals from qualified exterminating companies to provide pest control services for the Paraquita Bay campus buildings and grounds.
- The purpose of the contract aims to ensure the effective removal and ongoing prevention of pests, including rodents, to maintain a safe and pestfree environment across the College's facilities.

Scope of Services:

The selected Company will be expected to carry out exterminating services inside of all buildings and the grounds of the College.

- 6.A Valid BVI Trade License
- 7. Independently audited financial statements for the last two (2) fiscal years
- 8. A resume of comparable clients over the past five years
- 9. Details of claims handling procedures
- 10. A non-refundable fee of \$200
